Discuss The Scriptures

2. Why did God give the wife the role of subjection (1 Tim. 2:12-14; Gen. 3:16)?

3. What responsibility is enjoined upon the wife when it says she "must see to it that she respects her husband" (Eph. 5:33)? (See also 1 Pet. 3:2.)

4. What attitudes in a wife does God find precious (1 Pet. 3:1–6)?

5. What does it mean to "keep house" (1 Timothy 5:14)? Compare with "workers at home" (Titus 2:5) and Proverbs 31:10-31.

Discuss The Scriptures

1. How does the wife help her husband learn to be the head?

2. Is it unscriptural for a wife to work outside of the home (Prov. 31:13-24; Acts 16:14; 18:1-3)?

3. How can employment become abused (by either or both husband and wife) and so effect the marriage?

Apply The Scriptures

What can a wife do to maintain and improve her relationship after she has exhibited unrighteousness toward (or before) her husband?

"It is not good for the man to be alone; I will make him a helper suitable for him" (Gen. 2:18). Discuss how the wife helps the man with companionship, even though many men seem to not desire companionship.
